In the reference 5th cited, orders were issued with regard to the APEPDCL New Service Regulations for employees.

2. Objections have been received from certain employees against the above Service Regulations.

3. In this connection, it is to inform that these Service Regulations are applicable prospectively to the employees appointed hereafter by APEPDCL (with effect from 10.02.2022 i.e. from the date of approval of Government of A.P.) and employees recruited by any other Company and allotted to APEPDCL by Government, and employees recruited by any other Company and transferred to APEPDCL. However, these Service Regulations shall be applicable to all the Energy Assistants (JLM Grade-II) from the date of their recruitment. Further, in the said EOO (HRD) Ms. No.49, Dt.15.02.2022, it was mentioned that these Service Regulations shall come into force with effect from 10.02.2022 i.e. from the date of approval of Government of A.P.
