It is to inform that M/s Adani Energy Solutions Limited & M/s Adani Transmission Step Seven Limited are installing Smart Meters in the field as per the agreement vide reference 1st cited above.

The detailed procedure, along with the process flow screenshots to be followed by the Deputy Executive Engineers and Executive Engineers for carrying out Check Measurement of the installed meters, had been communicated vide the 2nd reference cited above. The same has also been made available on the APEPDCL website and can be accessed through the following link: <https://intranet.aeasternpower.com/smartMetersUpdates>

It is once again instructed to follow the below Check Measurement of installed meters procedure stringently without fail.

- a. Approval for all Smart Meters installed in the field LT and DTRs shall be granted by the respective Operations AEs.
- b. The respective **DEE Operations** are required to verify 5% of the installed Smart Meters against the SAT (System Acceptance Test) quantity for LT and DTRs, based on which the bills will be processed to M/s AESL.
- c. The respective **EE Operations** are required to verify 1% of the installed Smart Meters against the SAT (System Acceptance Test) quantity for LT and DTRs, excluding the meters already verified by the respective DEEs.

However, it is regretted to note that the Check Measurement activity has not been completed by any of the Deputy Executive Engineers/Operation and Executive Engineers/Operation, as per the required quantities.

All the DyEEs/Operation and EEs/Operation are requested to complete the Check measurements as per the requirement, i.e., **5% of the quantity by the DyEE and 1% by the EE** – in each section that has been approved by the respective AE.
